About this role:

The purpose of the Junior Counsellor role is to provide effective and high quality therapy to children and young people, 4yrs - 18yrs, in our Burton-Upon-Trent clinic.

- You will be required to conduct your own clinical assessments.
- You will work in an open-ended manner with clients.
- Clinical Supervision will be provided at a ratio of 1hr of supervision for every 6-9 client sessions, with a Qualified Serenity Clinical Supervisor.
- You must maintain appropriate membership with BACP, UKCP or NCS.
- You will meet your own requirements for CPD where necessary.
 (Serenity provides in house CPD opportunities 4 times per year and peer supervision groups each week which are both free of charge).
- You will be responsible for maintaining cleanliness of the room between working hours, ready for your colleague to enter.

- You will adhere to the BACP Ethical Framework and maintain confidentiality in accordance with Serenity's policy.
- You will attend one mandatory induction day before beginning sessions.

Person Specification - Junior Counsellor

Requirements:

You will be a fully qualified Counsellor/Therapist or studying towards one of these professions at the following levels:

- Diploma in Counselling (Level 4 or above).
- Degree, MSc or MA in Counselling, Counselling Psychology or Psychotherapy.
- If your course does not cover working with children, you must have relevant experience of direct work with children and young people.
- You will have completed the fitness to practice module of your course.
- You must hold membership with BACP, UKCP or NCS.

Experience:

- Your course must have practical and experiential learning. It can not be purely theoretical or distance learning based. Types of practical learning can include role play, triads and creative workshops using resources.
